## CCA PROGRAM OF INSTRUCTION

As a parochial school, *Christ Church Academy exists to educate students to become champions of truth living lives transformed by the love of God.* On mission with Christ Church Vero Beach, we emphasize faith, scholarship, service, and civics with an aim to make disciples who follow Jesus Christ.

Our Lower School program goal is to encourage and enable children to become independent learners who develop a life-long love of learning guided by a biblical worldview. This is accomplished through high-quality teacher interactions, play-based developmentally appropriate learning centers, and an active theological education aligned with faith doctrines of the Anglican Church of North America.

Educators use God's written word to integrate biblical truth into all disciplines of study. We strive to weave the wisdom and truth of God's word into the classroom experiences in such a way that students understand the relevance of scripture and apply it to every area of their lives.

The curriculum is guided by the National and Florida Education Standards; attends to the whole child; includes spiritual, social/emotional, physical, and cognitive development; and develops academic, cognitive, and social skills through exploration, problem-solving, and creativity.

Our curriculum focuses on developing students' skills in the critical areas of reading, writing, and mathematics with an integration of science, social studies, and technology. Teachers utilize a STEM scopes science curriculum, Sadlier and McGraw-Hill textbooks, and Positive Action for Christ; they combine hands-on experiences with high-quality literacy practices that promote effective and ethical uses of technology and knowledge.

We demonstrate the value of establishing solid, daily Christian values of self-discipline, love, and respect that are essential to a healthy society. Our students will experience Anglican traditions that foster their moral development to encourage integration of knowledge and biblical values so they may participate fully in their community of faith.

## ACADEMIC GRADING SYSTEM

Teachers observe and evaluate student academic progress, effort, conduct, and work habits. This information is used to guide instruction and address student needs. Formal evaluations are conducted on a quarterly basis, approximately nine weeks in length, with a report card issued at the end of each quarter.

Grades kindergarten through second use the word descriptors grading system as follows:

E: Exceeding Grade Level

M: Meeting Grade Level

P: Progressing Towards Grade Level

N: Needs Improvement

Grades three through five use a letter grade system and grades six through eight receive a number grade. The letter and equivalent number grades are as follows:

## WEEKLY CHAPEL

Lower School students participate in a weekly chapel service on **Thursdays at 9:30 am** in the Christ Church nave. Participation is active as worshipers and as leaders when selected to carry the processional cross, the processional Bible, or read an appointed scripture.

Families are encouraged to join their student(s) when possible for a time of introductory worship formation and a brief lesson. Each Chapel service is led by one of the Christ Church clergy members and includes praise, worship, Bible lessons and real life application of biblical principles.

## ADMISSIONS

Our admissions process is designed for the family and school to learn about each other. As the parochial school of Christ Church Vero Beach, CCA combines strong academics with the Christian doctrine and discipline of the Anglican Church in North America and is overseen by clergy and our accreditation agencies.

The CCA admissions application includes: (1) a completed application, (2) birth certificate, and (3) family interview. Admissions to the school is an annual decision and based on, but not limited to, the family interview, academic performance, and student services needed.

## TUITION AND FINANCIAL OBLIGATIONS

**Early, Extended, and Friday Care Programs are available at an additional cost.**

Parents will pre-select one of the payment plans listed on the Lower School Application. **Invoices are emailed on the first of every month** for the current month's tuition plus any extended care charges from the prior month and include a link to pay with a credit card or bank account.

Accounts become delinquent when unpaid amounts are 30 days past due. **Unpaid fees will be assessed a \$40.00 late fee starting on the 10th day after the payment due date;** charges accumulate as long as the account remains past due. *When requested in advance, a grace period up to 30 days may be granted from the Head of School.* A grace period beyond 30 days requires an approval from the Head of School prior to the payment due date. Report cards, school records and future registration will be held until tuition and fees are paid in full or a payment arrangement has been made.

\*Families who become members of Christ Church Vero Beach after school starts will have their tuition adjusted to the member tuition rate the month following they date they joined the church.

## TUITION ASSISTANCE

Parochial school education is an investment in both academic and spiritual formation. God has high expectations of parents and the Bible strongly emphasizes raising children in a biblical manner. In certain situations, CCA may be able to offer tuition assistance to help families if the Step Up funds available are insufficient.

Tuition assistance is provided on the basis of financial need and is not intended to cover the total cost of tuition and fees. There will always be some level of family contribution. Applicants must first complete the academic enrollment process. An applicant's financial solvency is not a factor in the admissions decision. CCA does not provide merit-based scholarships.

### Steps to Assistance

1. Students must be re-enrolled or have applied to enroll in CCA to be eligible for tuition assistance.
2. Students must have applied for Step Up funding.
3. Applications should be requested from and returned to the CCA Office as soon as possible after tax documents are finalized because tuition assistance resources decrease rapidly beginning in April.
4. The CCA Financial Aid Committee reviews all requests and recommends the amount of qualified need toward the tuition bill. Assistance is awarded upon a combination of factors including: what the family qualified for, filing date of the application for tuition assistance, and the amount of funds available for disbursement.
5. The CCA Financial Aid Committee then approves or denies the recommended assistance amount and the final decision is communicated to the family in confidence.
6. A returning student is given preference in the award process and we are committed to helping students continue their education at CCA if the family qualifies, and if tuition assistance funds are available.

## FAMILY VOLUNTEER HOURS

Each school family is asked to **volunteer a minimum of 10 hours to the school** each year. The PPA (Parent Parish Association) is the place to see where your talents and energies fit in. Alternatively, you can choose the opportunity to provide goods for an event in lieu of service hours if you are unavailable to serve in person. Generally, \$20.00 is equivalent to 1 hour of service. See Head of School, Mr. Gammell or the PPA president for more information.

## SCHOOL TARDINESS & ABSENCES

**Classes begin promptly at 8:30 a.m.** Students arriving after this time will be marked tardy. Tardiness is contrary to our learning environment as well as to the principles of self-discipline, accountability, and consideration for others. After three tardies a \$20.00 fee, per infraction, will be assessed.

An excess of 20 absences per school year will result in a formal notice from the Head of School and may affect continued enrollment and/or promotion to the next grade. Excessive tardiness may warrant dismissal from CCA.

## MAKE UP WORK

**Excused Absences:** Students are responsible to make up work. Parents are responsible for coordinating with teachers if requesting advance assignments. Parent should request picking up the day's assignments 9:00 am via email. Work must be completed within three school days after returning unless otherwise arranged with the teacher.

**Unexcused Absences:** Teachers are not required to communicate with parents during an unexcused absence. Upon return. Students/parents must seek teacher approval to make up class/homework assignments. Work must be completed within three school days after returning unless otherwise arranged with the teacher.



## PROMOTION/RETENTION POLICY

We anticipate students are capable of learning on grade level and expect they will be promoted to the next grade at the end of the academic year. When our teachers observe a student with learning challenges, they follow these steps to pursue academic success for that child:

1. A Student Interest Team, composed of the Head of School, the core teacher, and parents, will gather to assess information regarding the student's performance in class and at home.
2. A specific Intervention Plan will be developed and implemented at school (and at home, if appropriate).
3. The student's progress will be monitored and reviewed as needed, and all alternatives to grade-level promotion or retention will be explored.

Promotion to the next grade level may be contingent upon the completion of coursework through a summer remediation plan. Retention will be recommended and implemented only after careful consideration and evaluation by teachers and parents. The decision to retain a student rests with the Head of School.

## WITHDRAWAL POLICY

If a student is withdrawn from CCA enrollment for any reason after classes have begun, the parents are obligated to pay the full tuition for that quarter.

For a student withdrawal to be official, parents must complete a Withdrawal Form that includes signatures from teachers and other school personnel. Until a Withdrawal Form is formally submitted to the Head of School, the student status is considered enrolled. Student records and transcripts will be held until all outstanding financial obligations are paid in full and when all textbooks and CCA materials and/or equipment are returned.

If a student is expelled, the tuition for the remainder of the school year will be waived, however, tuition for the remainder of the month will not be reimbursed.

## CCA FAMILY COMMUNICATION

Our school family culture relies on effective and regular communication. Teachers use their CCA email as the primary way of sharing information with parents such as grades, upcoming assignments, and lesson plans. Our monthly newsletter, *The Lion's Roar*, is distributed via email.

Additionally, you may request to join our private Facebook page or follow us on Instagram.

## CHANGE OF INFORMATION

The responsibility to notify the school of any change of address, phone number or email is on the parents/guardians. This information is essential for our emergency and health information records and communication from teachers and administrators.

It is also important to notify the school in the event of a job change or custodial change. Custodial changes must be accompanied by legal documentation.

## PARENT-TEACHER CONFERENCES

**Conferences must be scheduled.** Drop-off and pick-up are not appropriate times, nor are school functions, as teachers have other assigned duties.

All questions, concerns, or insights regarding a student, academics or the classroom should first be addressed to the teacher involved for resolution. Concerns about school operations should be made to the Head of School. Expect a response within 24 hours.

Any unresolved issues may be directed to the Head of School or the supervisor of the area of concern.

Parents are expected to attend the scheduled parent/teacher conferences each quarter and are welcome to request teacher conferences throughout the year. Request a teacher appointment in advance by email or handwritten note.

## PARISH PARENT ASSOCIATION

As a parochial school, we enjoy community with Christ Church Vero Beach, the members of which support the school with resources and prayer. All parents and/or guardians of enrolled students and parishioners are members of the Parish Parent Association. The primary goals of the PPA are communication, education, and service, but it also provides opportunities for parent and parish fellowship throughout the school year. The PPA is led by a parent/guardian volunteer who works closely with CCA administration and faculty to help facilitate school functions, fundraising and service projects.

## FUNDRAISING

Christ Church Academy has a few fundraisers each school year that offset expenses and help keep tuition affordable. The annual Lions Gala is our key event of the year and we depend on parent participation to make it a success. **No student or parent will ever be asked to go door-to-door to sell anything.**

## BIRTHDAYS AND HOLIDAY CELEBRATIONS

Pending teacher approval, your child may celebrate his/her birthday in the classroom. Children are not permitted to hand out party invitations at school unless the whole class is invited.

CCA respects the right of parents to celebrate the holidays of Halloween, Christmas, and Easter with their families as they wish. On campus and in our classrooms, however, the following principles will serve as our school guidelines:

**Decorations and activities involving witches, monsters, ghosts, death, and fear are prohibited**, even for Halloween.

At Christmas and Easter, we emphasize the virgin birth of Jesus Christ and his resurrection. Secular symbols such as Santa Claus, elves, and the Easter Bunny are de-emphasized but not prohibited.

## FIRE DRILLS & EMERGENCY PREPAREDNESS

CCA regularly conducts safety/emergency drills. The school maintains a log containing the date of the drill, the number of children participating, an attendance roster to indicate that all children have safely evacuated the facility and returned after the drill is completed, the time taken for a full evacuation to be completed, and any special conditions that occurred. If you are on campus during a drill, please participate as directed.

## SCHOOL CLOSINGS AND SEVERE WEATHER

If the school must close unexpectedly for any reason, all families and personnel **will be notified by email**. Notices may also be posted on the CCA website, Facebook or Instagram.

In the event of unexpected severe weather, we will shelter in place in an interior room until the danger has passed.

## FIRST AID

We stock basic first aid items and **every classroom has at least one teacher who is First Aid, CPR, & AED certified.**

In the rare event of injury, we will apply first aid. Our standard procedure for open wounds is antibiotic cream/spray with a bandage. We do not dispense oral medication. Minor injuries (i.e., a scrape) will be reported at pick-up time, but more serious injuries will be tended and the parents notified immediately.

## ILLNESS AND PUBLIC HEALTH

Students ***must*** stay home from school if they have had a fever, **runny nose, cough, diarrhea, or vomiting** within the **preceding 24 hours or currently exhibits any of these symptoms**. Students exhibiting these symptoms will be sent home early.

We understand the inconvenience of unexpected illness, but knowingly transmitting the illness to others by sending a sick child to school is inconsiderate. Parents are responsible to have contingency plans with another caregiver in the event the student cannot attend school.

## DRESS CODE

Uniforms are available exclusively at School Uniform Apparel of Vero Beach, 772-563-0777.

**Approved apparel** is a CCA logo shirt (tucked in); khaki pants, shorts, or skort; a belt; closed toe shoes. A solid gray sweater is optional. Sandals are prohibited.

Dress code standards apply while the student is on campus during school hours. Faculty may request the removal of any item that is deemed a distraction to the educational process or is in violation of the dress code. CCA requires a school uniform to eliminate distractions and create an environment conducive to learning, and to encourage responsibility for one's physical appearance.

## DISMISSAL

Students are dismissed at 3:30 pm from inside the east playground to the appropriate vehicles in the pickup line. Students not picked up by 3:45 will be assigned to our Lower School Extended Care Program (3:45 - 5:30 pm) for an hourly cost and parents will need to check them out of school from the inside kiosk.

Parents requesting early dismissal must contact the school via email or phone. Email Mr. Gammell ([bgammell@ccavero.org](mailto:bgammell@ccavero.org)) or Mrs. Young ([iyoung@ccavero.org](mailto:iyoung@ccavero.org)) or call (772) 562-8670 to coordinate the pick up arrangement.

## LUNCH/FOOD POLICY

We do not have a cafeteria lunch program. Students must bring a packed lunch. Glass containers are prohibited.

## PERSONAL ITEMS

Please leave toys and non-essential items at home to avoid loss and arguments. Items that interfere with the learning environment will be held by the teacher and returned to the parent.

Please label your child's belongings to assist identification.

## SCHOOL PICTURES

School pictures are taken in the fall by a professional photographer, and students are required to wear standardized school uniforms. The purchase of portraits is optional.

## DISCIPLINE PHILOSOPHY

Scripture refers to discipline as training the heart and focuses on the condition of the heart as the source of everything we say, desire, and do. CCA is a community of grace and truth, and appropriate discipline goes deeper than just imposing a consequence. We aim to help students understand the condition of their own hearts based on the morals and values found in God's word.

We acknowledge that parents hold the primary responsibility for their children's discipline and maintain that parental involvement is integral to discipline within the school program. It is further understood that to maintain continuity and integrity in our school community, the Head of School retains the right and responsibility to administer disciplinary action to teach and model biblical repentance, forgiveness, and restoration.

Each classroom teacher has the primary responsibility for student discipline and will initiate parental contact when necessary. Students will be referred to the Head of School for disciplinary action for consistent classroom infractions, gross misconduct, and moral and/or ethical offenses. Failure to serve any assigned discipline will result in additional disciplinary action.

CCA is not required to follow a certain progression of disciplinary action and may proceed immediately with expulsion as circumstances warrant and when deemed appropriate by the head of school.

**Parents/guardians are held to the same moral and ethical standards as students with regard to all things CCA.**

## BEHAVIORAL EDUCATION

**School rule:** *Love and respect God and each other.*

This standard creates an “others awareness” when learning self-control, how to share and take turns. It takes practice and patience to help students understand the difference between acceptable and unacceptable behaviors. CCA references Galatians 5:22-23, the fruit of the Spirit, to teach students about God’s gracious character and how his disciples learn to act and think like him.



## CORRECTIVE MEASURES FOR MISCONDUCT

**Detentions:** Teachers may assign classroom or lunch detentions.

**Expulsions:** Students who do not respond to corrective measures, continue to exhibit negative behaviors or attitudes, are involved in serious misconduct, or bring discredit to CCA, are subject to expulsion. Expulsions may be appealed to the Head of School in writing within ten days of the decision. CCA reserves the unilateral right to deny admission or continued enrollment of a student when it is not in the school's best interest.



## MAJOR INFRACTIONS REQUIRING CORRECTIVE MEASURES

Conduct that warrants immediate referral, resulting in disciplinary action includes, but is not limited to, the following:

1. Disrespect to a staff member
2. Blatant disobedience or serious class disruptions
3. Profanity, obscenity, and/or vulgar speech
4. Striking with the intent to harm, causing harm to another or any threat or action that endangers the lives of others
5. Inappropriate use of social media
6. Lying or deception
7. Inappropriate physical contact between students
8. Skipping class or school
9. A serious breach of conduct (including violation of civil law)
10. Vandalism of school property (including pulling fire alarm)
11. Theft of personal or school property
12. Possession/use of alcohol, illegal drugs, tobacco or vaping products on campus or at CCA-sponsored events
13. Possession of a weapon: an object used to inflict harm or to intimidate another person, including, but not limited to, knives, guns, chains, pointed instruments, razor blades, etc.
14. Bullying: repeated, systematic, targeted infliction
15. Cyberbullying: any activity using technology interpreted to inflict harm against any member of the CCA Community on or off the campus
16.
