



## 2024 EARLY, EXTENDED, FRIDAY CARE PROGRAMS

Christ Church Vero Beach offers before and after school care for CCA families only. The program includes time for rest, arts & crafts, organized play, and snacks; enabling students to further develop their social, physical, and intellectual skills and talents. Our mission is to provide a safe, secure, and nurturing environment. Personal items (toys, pillows, blankets, etc.) are prohibited. **Programs are for days that school is in session.**

**Billing/Payment:** Early Care is \$7.00 per family. After Care is \$7.00 per family. All-day Friday Care is \$45.00 no matter the length of stay. Statements are processed monthly with payment due within 15 days of the billed date. **Late charge:** Students must be picked up by 5:30 pm; after a five-minute grace period, a \$20.00 late fee will be assessed. Excessive lateness may result in discontinued service.

**Sign-out Procedure:** Parents must electronically check out their student(s) before retrieving them. *Parents will also sign the aftercare log located in the classroom.* Student(s) will only be released to an adult, for whom written authorization has been given. Parents are responsible for updating Early, Extended & Friday Care records.

**Snacks:** Parents must provide food and drink for snack time, if desired. A regular supply of spring water is always available.

**Rest Mats:** Parents provide "quiet time" mats which are regularly cleaned, disinfected and stored on site. Mats (Children's Factory 2") may be purchased online at Discount School Supply, 1-800-879-3753.

**Behavior:** Students are expected to conduct themselves in a Christian manner; respect for authority, each other, and Christ Church Vero Beach. Program personnel have authority to take corrective measures regarding student behavior as deemed appropriate. In all cases, the head of school has the final say as to what behavior warrants corrective measures. Unacceptable behavior may be grounds for dismissal.
